Another steady rise in passenger numbers, rising 3.6% (incl Transit), with the Moving Annual Total now showing a 4.8% increase. Scheduled international numbers are showing the way with a 12.7% increase compared to reductions in Domestic (-8.0%) and Charter (-5.8%). The freight volume has reduced (-15.2%) for the 4th month in a row. This is worrying as the passenger figures normal mirror the freight ones a few months later.
